Procedures for Submitting Requests

- All three of the attached forms must be completed, and properly signed prior to submission to the District for approval. (<u>Application and Permit</u>, <u>Agreement of User to Hold Harmless</u>, <u>Statement of</u> <u>Information</u>)
- 2. Please submit all information to the office at the site you wish to use. In addition to the three forms, you must include a copy of your organizations <u>certificate of insurance with an additional insured endorsement</u> naming **Sierra Unified School District**, its officers, board members, agents and employees as additional insureds to the commercial general liability policy. If the Certificate of Insurance and additional insured endorsement is not immediately available, please attach a statement that includes a) name of the insurance company and contact person, b) date that you made a request for a certificate, and c) the estimated date the certificate will be received by the **Sierra Unified School Distric**. **Important:** Prior to the scheduled event, the <u>Certificate of Insurance and additional insured endorsement must be received by the District. The acceptable limits of coverage are \$2,000,000</u>

per occurrence and \$4,000,000 aggregate.

- 3. Rental fees and or charges for services will be paid for at the site to be used when the above named forms are presented and approved.
- 4. For information on the cancellation policy, contact the District Office.
- 5. If you have any questions about the procedures, please refer to them to the District Office.
