In addition to the three forms, you must include a copy of your organizations certificate of insurance with an additional insured endorsement naming Western Sierra Charter School its officers, board members, agents and employees as additional insureds to the commercial general liability policy. If the Certificate of Insurance and additional insured endorsement is not immediately available, please attach a statement that includes a) name of the insurance company and contact person, b) date that you made a request for a certificate, and c) the estimated date the certificate will be received by the Western Sierra Charter School Important: Prior to the scheduled event, the Certificate of Insurance and additional insured endorsement must be received by the District. The acceptable limits of coverage are \$2,000,000 per occurrence and \$4,000,000 aggregate.
- 3. Rental fees and or charges for services will be paid for at the site to be used when the above named forms are presented and approved.
